

This is written pursuant to our telephone conversation earlier today regarding the Flood Insurance Study Revision for the Town of Peterborough. Your letter dated July 30, 2003 requested documentation of notice to potentially impacted property owners. We have been working with the community to accomplish the notice requirement.

To date, the notification process has not been completed. We anticipate that it will be completed by November 30, 2003 and therefore we request a 30-day extension to complete the notification requirement.

In addition, DELTA is reviewing the revised HEC-RAS models that you transmitted to us earlier this month. We expect that our review will also be completed by November 30, 2003.



Dear Ms. Ogilvie:

As we have discussed, the Town of Peterborough needs to notify potentially impacted property owners of the floodway revision along the Contoocook River. This information is necessary for FEMA to complete the Flood Insurance Study Revision for Peterborough.

Enclosed are maps showing the section of the Contoocook River that has a revised floodway. Two maps detail the new floodway revision and show the location of the old floodway. The other map shows the old floodway location.

Please notify the property owners in the vicinity of the new floodway revisions and send copies of the property owner notification to DELTA.

We suggest the following language:

"The Town of Peterborough has completed a comprehensive reanalysis of the flood hazards throughout the town. As part of the project, the floodway along a portion of the Contoocook River in the vicinity of the former municipal landfill, has been revised. The resulting change shifted the floodway to the south on property that our records indicate you are the owner of record.

This letter is written to provide you with notice of the proposed revision in accordance with federal regulations. If you have any questions regarding this matter, please contact the Office of Community Development at (603) 924-8000."
